- 1. SetPoint Staffing shall provide the Client with such employees who are qualified to serve in the capacity specified by the Client. Upon prompt notice (within the first three hours of the assignment) from the Client, SetPoint Staffing will not charge for such employee's unsatisfactory service and will attempt to promptly supply a replacement employee. Individuals supplied by SetPoint Staffing to Client are at all times to remain employees of SetPoint Staffing and shall be covered under SetPoint Staffing workers compensation insurance policy.
- (including worker's compensation claims), expenses and/or liabilities arising from or in connection with the performance of the employee. 2. Client agrees to release, defend and hold harmless (SetPoint Staffing (together with SetPoint Staffing officers, directors, employees, successors and assigns) from and against any claims
- 3. Client will be billed weekly. Payment is due upon receipt of invoice. Client will be billed for the hours shown on the timesheet at the agreed upon rate.
